*For students starting and ending services after the beginning of the school year, fees will be prorated on a monthly basis, when prearranged with our finance assistant, Karen Yelovich. (Contact her at steptersfinancials@gmail.com)

** If morning or aftercare is requested **without** the 24-hour advance notice, parents will be charged the \$40.00 Drop-In fee.

<u>Availability:</u> Our day care operates on every instructional day. It does not operate on non-school days. Before care will open at 6:45 a.m. and will continue until the start of school. After care will open as soon as the school ends and will close at 6:00 p.m.

<u>Drop-In Care:</u> Drop-In care is available for all St. Peter's students. Fees are charged per session, with before care and after care each being a session (e.g. using both sessions will cost two fees).

<u>Scheduled Half Days:</u> Students who are enrolled in after care 4 or 5 days/week are eligible to receive after care beginning at noon on scheduled half days at NO ADDITIONAL COST. All other students enrolled in St. Peter's Day Care may attend on half days by prior arrangement only. The Drop-In care fee will be assessed. Half-day care is not currently available for students who do not otherwise participate in before/after care.

<u>Monthly Payment:</u> The monthly payment is the annual cost divided by 9. Payments are due on the first of each month from September through May. The preferred payment method is through FACTS but check or cash is also accepted.

<u>To Parents using After Care Services</u>: After Care operates until 6:00 p.m. All students must be picked up by that time to avoid being charged an overtime fee. The fee is \$1.00 per minute after 6 p.m.

Any child not registered in the Before & After Care Program who is not picked up at dismissal by 3:30 p.m. will be sent to After Care at an additional fee.
