Registration Fee*	\$350.00	This fee is per student . It must be received by March 1, 2024 and is non-refundable .
Book/Technology Fee*	\$350.00	This fee is per student . It must be received by May 1, 2024 and is non-refundable .
Graduation Fee	\$75.00	(Fifth Grade Only) Payment is due on or before August 1, 2024.
Annual Tuition**	\$6,800.00	(Pre-Kindergarten through 5 th grade) This may be paid in 10 monthly payments of \$680.00. Your first payment is due by August 15, 2024.
Multi-Child Discount	\$680.00	The eldest child is assessed at full tuition. Each additional child is discounted 10% per child.

Involved Member Grant	\$680.00	St. Peter's Lutheran Church offers an <i>Involved Member Grant</i> for students with parents or grandparents who are current, active members of St. Peter's Lutheran Church OR
Attendance Grant	\$1,000.00	If the worship attendance requirement (20) has been met, you may qualify. St. Peter's Lutheran Church will award the discount.
Tuition Paid in Full Before September 1, 2024		\$150.00 discount
FACTS Fee	\$50	Per family (if payments are quarterly or monthly) A FACTS account must be set up no later than July 1, 2024 payment date, and can be set up as early as April 2024. This is automatically withdrawn by FACTS when the account is set up.

In addition to the non-refundable Registration and Book & Technology fees, families will be responsible for a \$1,000.00 **Student Withdraw fee if students are withdrawn between August 26, 2024, and September 3, 2024.

Please note the following regarding fees and tuition:

1. Children will not be permitted to attend school until the Registration Fee, Book/Technology Fee, and the first month of Tuition has been paid. No exceptions.
2. All Tuition, Book/Technology Fees and Graduation Fees which are paid by cash or check are due on or before August 1, 2024.
3. All families are required to use the FACTS automatic debiting service, without exception. You may set up your account to have these obligations automatically withdrawn as early as May 2024. Your first payments are due no later than their August 15, 2024.
4. The Graduation Fee, for fifth graders only, will cover the cost of a yearbook, diploma, a graduation cap, the graduation program, invitations, and flowers.
5. A flat tuition reduction of \$1,000.00 will be applied for any family referring a new student who registers, enrolls, and attends in any grade for an entire year.

Notification of the Maryland State Non-Public Textbook Program

Each year our principal applies for money awarded by the Maryland State Non-Public Textbook Program, which is similar to a grant. This wonderful opportunity allows all of our St. Peter's families to benefit from a significant savings on textbooks and other required learning materials each year. In turn, the money that we receive lowers the actual amount of the Book and Technology fee payment (\$350.00) that we charge. That fee would be much higher without the assistance that MSDE makes possible. We are so grateful for their help.
